Kentucky ranks first (worst) in the country in health outcomes for expectant mothers according to the Centers for Disease Control and Prevention (CDC). Over fifty percent of these deaths are due to maternal Opioid Use Disorder (OUD), lack of access to prenatal OUD treatment and poor transitions in the perinatal period.

Health systems frequently are not prepared for this complexity, and older adults suffer a disproportionate amount of harm while in the care of the health system.
