President Trump will invoke Defense Production Act to boost medical supplies

President Trump announced from the White House Briefing Room Wednesday that he will invoke the [Defense Production Act](#), which will speed up and expand the supply of resources from the country's industrial base, particularly to increase the production of medical supplies and equipment. It's a move that has been under discussion in recent days and weeks, as the country lacks a sufficient number of ventilators, masks, and other critical items needed to meet the coming demand due to the coronavirus pandemic.

Vice President Mike Pence said the U.S. has a stockpile of roughly 10,000 ventilators, and the U.S. military will be adding more.

Mr. Trump also announced health officials are working on a "self-swab" coronavirus test, which he suggested would be more comfortable and more "popular" than the current test, as the administration scrambles to provide more tests. The main complaint from hospitals and doctors is that they lack enough tests, not that the tests are uncomfortable. The president has asked all Americans to limit contact with others for 15 days.

The number of confirmed COVID-19 cases worldwide now tops 200,000, according to Johns Hopkins University.

US Navy is deploying a fully-equipped hospital ships to help in the fight against the coronavirus in New York

(Business Insider) The US Navy is preparing its hospital ships to help in the fight against the coronavirus pandemic in the hardest-hit communities in the country.

Defense Secretary Mark Esper confirmed he ordered the Navy to "lean forward" in deploying two of its hospital ships, the USNS Comfort and USNS Mercy, during a press conference on Tuesday.

The Comfort, based in the East Coast at Norfolk, Virginia, is currently undergoing maintenance; while the Mercy is at port in San Diego, California.

The two ships will specifically focus on trauma cases if deployed, given the limited amount of space aboard the ships, Esper said. The plan is to alleviate the burden on traditional hospitals dealing with a high number of patients with the coronavirus.

State lab running low on testing supplies

In a video briefing today with HPP Regional Coalition partners, Dr. Doug Thoroughman, a CDC Epidemiologist serving as the Interim State Epidemiologist, told the audience that the state lab is almost out of the testing materials they need to actually run the COVID-19 tests. They have additional materials due in tomorrow, but they may reach a point, as other states have experienced, where they are going to have to stop testing until they get resupplied.

What Dr. Thoroughman suggested is that local health care facilities and providers consider using commercial labs which have indicated that they have ample testing materials. Check with your lab to see what their sampling and shipping requirements are, and be advised that some of the commercial labs have a longer turn-around time.

The state is hoping that the testing process will eventually be entirely based on the private labs, some university-based labs, and those hospital labs which meet the FDA's criteria. At that point they will return to their normal role as a confirming and validating lab where needed.

U.S. Virus Plan Anticipates 18-Month Pandemic and Widespread Shortages

(NY Times) A federal government plan to combat [the coronavirus](#) warned policymakers last week that a pandemic “will last 18 months or longer” and could include “multiple waves,” resulting in widespread shortages that would strain consumers and the nation’s health care system.

The 100-page plan, dated Friday, the same day President Trump declared a national emergency, laid out a grim prognosis for the spread of the virus and outlined a response that would activate agencies across the government and potentially employ special presidential powers to mobilize the private sector. The plan, which was unclassified but marked “For Official Use Only // Not For Public Distribution or Release,” was shared with The New York Times.
