Kentucky sees record number of COVID-19 cases for second-straight day

(WDRB) Eight more Kentuckians who have tested positive for COVID-19 have died, Beshear said. Seventy-three deaths throughout the state have been linked to coronavirus so far. At least 339 people have fully recovered from the coronavirus so far, with 205 Kentuckians hospitalized and 93 in intensive care, Beshear said. Beshear also renewed his executive order allowing pharmacists to use telehealth services to renew prescriptions.

KY Doctor arrested for attacking teen girls, choking one, apparently for not social distancing

(NBC) A Kentucky doctor who violently attacked a group of teen girls, choking one of them, apparently for failing to practice social distancing, was arrested after a video of the incident went viral over the weekend. The video, which was posted to Reddit and titled, "Man strangles teenage girl for failing to social distance," shows a man approach at least four girls who are on a picnic blanket. A woman near him appears to film on her phone as one of the girls tells them the group is leaving.

A statement from Baptist Health Louisville said Rademaker was a contract physician with the provider but "has been placed on administrative leave from his practice and is not providing services at a Baptist Health facility."

More than 10% of Kentuckians Who've Tested Positive For Coronavirus Are Health Care Workers In Jefferson County

(WFPL) A nationwide shortage of medical supplies has left Kentucky hospitals scrambling for every piece of protective equipment they can find as more than a hundred healthcare workers in Louisville test positive for COVID-19.

Without an influx of equipment, healthcare workers on the frontlines in cities including Louisville are stretching the masks, gowns and gloves that remain.

"We walk into the hospital. We get our temperatures taken and then we are given a mask that we have to wear for a 12 and a half hour shift," said one Norton employee who requested to remain anonymous.

At least 113 healthcare workers in Jefferson County have tested positive for COVID-19 as of Monday, according to information from the county's three major hospital systems.

There were 1,008 cases across the state on Monday — meaning about 11 percent of all those who have tested positive in Kentucky are healthcare workers in Jefferson County.

(AP) As health officials around the world push to get more ventilators to treat coronavirus patients, some doctors are moving away from using the breathing machines when they can.

The reason: Some hospitals have reported unusually high death rates for coronavirus patients on ventilators, and some doctors worry that the machines could be harming certain patients.

The evolving treatments highlight the fact that doctors are still learning the best way to manage a virus that emerged only months ago. They are relying on anecdotal, real-time data amid a crush of patients and shortages of basic supplies.

Feds eye loosening rules to allow some to return to work

(AP) In a first, small step toward reopening the country, the Trump administration issued new guidelines Wednesday to make it easier for essential workers who have been exposed to COVID-19 to get back to work if they do not have symptoms of the coronavirus.

Dr. Robert Redfield, director of the the Centers for Disease Control and Prevention, announced at the White House that essential employees, such as health care and food supply workers, who have been within 6 feet of a confirmed or suspected case of the virus can return to work under certain circumstances if they are not experiencing symptoms.

The new guidelines are being issued as the nation mourns some 13,000 deaths from the virus and grapples with a devastated economy and medical crises from coast to coast. Health experts continue to caution Americans to practice social distancing and to avoid returning to their normal activities. At the same time, though, they are planning for a time when the most serious threat from COVID-19 will be in the country's rear-view mirror.

Louisville's UPS Hub Partners With FEMA To Distribute Medical Supplies

(WFPL) On Sunday night, a UPS 747 landed in Louisville from Shanghai, China, with more than a million masks, swabs and other critical medical supplies needed amid a countrywide shortage.

The flight is one of 25 in support of Project Airbridge, a coordinated effort between UPS, the Federal Emergency Management Agency (FEMA) and others to distribute supplies needed in U.S. hospitals.

At the same time, UPS's Healthcare division has opened a 450,000 square foot warehouse in Louisville that includes dedicated space for a FEMA distribution center.

FEMA Administrator Pete Gaynor [tweeted](#) that Sunday night's flight included 1.19 million masks, 682,400 surgical gowns and two million medical swabs.

A similar planeload of supplies landed in New York city on Sunday night, [according to NPR](#). That equipment is destined for New York, New Jersey, Connecticut and other high-risk areas.

In total, UPS says the partnership plans on moving more than three million pounds of supplies over the next two weeks, according to the press release.

The 3 key points of the overall guidance are:

1. All U.S. healthcare facilities should begin using PPE contingency strategies now and
2. U.S. healthcare facilities experiencing PPE shortages may need to consider crisis capacity strategies, which must be carefully planned before implementation.
3. As PPE becomes available, healthcare facilities should promptly resume standard practices.
