Governor Outlines Road Ahead for Gradual Reopening of Businesses

(Frankfort) Gov. Andy Beshear on Wednesday laid out the state's plan to gradually reopen business activities while continuing to keep Kentuckians safe from the novel coronavirus 2019 (COVID-19). The Governor unveiled a tentative reopening schedule for a variety of businesses allowed to resume operations. However, he cautioned that in all cases, it will not be business as usual and will require adherence to [the 10 rules to reopening](#), along with industry specific requirements.

Case information: As of 5 p.m. April 29, Gov. Beshear said there were at least 4,539 coronavirus cases in Kentucky, 184 of which were newly confirmed. Unfortunately, Gov. Beshear also reported 10 new deaths Wednesday, raising the state's toll to 235 deaths related to the virus. Today's totals for cases and deaths include one that is being listed as a "probable case."

Fauci says data on remdesivir raises COVID-19 hopes

(Reuters) The top U.S. infectious disease official said Gilead Sciences Inc's experimental antiviral drug remdesivir will become the standard of care for COVID-19 after early results from a key clinical trial on Wednesday showed it helped patients recover more quickly from the illness caused by the coronavirus. Preliminary results from a U.S. government trial showing that patients given remdesivir recovered 31% faster than those given a placebo, were hailed by Dr. Anthony Fauci as "highly significant."

Interest in remdesivir has been high as there are no approved treatments or preventive vaccines for COVID-19, and doctors are desperate for anything that might alter the course of the disease that attacks the lungs and can shut down other organs in severe cases.

The new data "offers a glimmer of hope" that remdesivir has an effect against COVID-19, but more scientific analysis is needed "comparing them to other studies of the drug that have shown mixed results," he said in a statement.

Also on Wednesday, results were published by the Lancet medical journal of a trial conducted in China that concluded remdesivir failed to improve patients' condition or reduce the pathogen's presence in the bloodstream. Gilead said previously that those findings were inconclusive because the study was terminated early.

U.S. coronavirus outbreak soon to be deadlier than any flu since 1967 as deaths top 60,000

U.S. deaths from the novel coronavirus topped 60,000 on Wednesday and the outbreak will soon be deadlier than any flu season since 1967, according to a Reuters tally.

America's worst flu season in recent years was in 2017-2018 when more than 61,000 people died, according to the U.S. Centers for Disease Control and Prevention [here](#)

The only deadlier flu seasons were in 1967 when about 100,000 Americans died, 1957 when 116,000 died and the Spanish flu of 1918 when 675,000 died, according to the CDC.
