## Fauci warns Kentucky and its neighboring states to stem coronavirus numbers to avoid a surge 'we just can't afford'

(CNN) Dr. Anthony Fauci on Tuesday warned several states including Tennessee, Ohio, Indiana and Kentucky to get a handle on [rising coronavirus cases](#), saying the nation couldn't afford the kinds of surges seen further south and west.

Fauci's comments to ABC's "Good Morning America" echoed fellow White House coronavirus task force member Dr. Deborah Birx, who recently [visited those states](#) to warn their numbers were headed the wrong way.

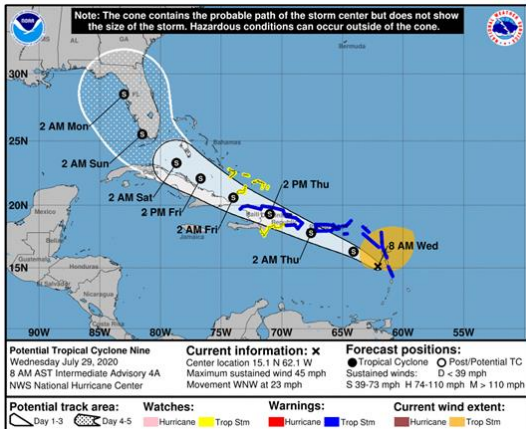
## 21 states now in federal 'red zone' for serious coronavirus outbreaks: study

(The Hill) Twenty-one U.S. states are currently in the "red zone" for coronavirus outbreaks under federal criteria, reporting more than 100 new cases per 100,000 people in the last week, according to a new federal report.

Those states are Alabama, Arizona, Kansas, California, Florida, Georgia, Idaho, Iowa, Kansas, Louisiana, Mississippi, Missouri, Nevada, North Carolina, North Dakota, Oklahoma, South Carolina, Tennessee, Texas, Utah and Wisconsin, [according to The New York Times](#). Three of the states — Missouri, North Dakota and Wisconsin — had not been on the list when the last edition of the federal report was published in mid-July.

## Developing Problem - [Potential Tropical Cyclone Nine](#)



(ASPR) Forecast: At 8 am EST, the disturbance was centered 350 miles east-southeast of San Juan, Puerto Rico with maximum sustained winds of 45 mph and a minimum central pressure of 1005 mb. The system is moving toward the west-northwest near 23 mph. On the forecast track, the center will move near or over the Virgin Islands and Puerto Rico tonight, near or over Hispaniola on Thursday, and near or over the southeastern Bahamas on Friday. The system is forecast to become a Tropical Storm later today.

[R Bartlett note - Even before we potentially get visited by the remnants of this storm, there is some heavy rain in our forecast. Here is a rundown from the National Weather Service for the next week.)

(NWS Louisville) Thursday through Tuesday - Periods of showers and thunderstorms are will occur into the weekend. Very heavy rainfall will be possible with some of the storms, especially on Thursday. Widespread rainfall totals will approach 2-4 inches by Sunday, with locally higher amounts capable of causing localized flooding. The favored location for heaviest rainfall is south of Interstate 64.

(NWS Paducah) Thursday through Tuesday - Scattered to numerous thunderstorms are expected Thursday into Thursday night. Lightning, locally heavy rain, and gusty winds are the main concerns. A few strong to severe thunderstorms may produce damaging wind gusts by Thursday afternoon and evening. Scattered thunderstorms are forecast Friday and Saturday. Though locally heavy rainfall looks to be the primary concern at this time, a few stronger storms cannot be ruled out from mainly southeast Missouri eastward across western Kentucky. Isolated thunderstorms will still be possible over parts of the region Sunday, but with much less heavy rain potential.

(NWS Jackson) Thursday through Tuesday - Thunderstorms are possible at times from Thursday through Tuesday and will be most widespread during the afternoon and evening hours. Periods of heavy rainfall can be expected Thursday into Friday resulting in a widespread 1 to 2 inches of rain for a good portion of the area. Localized rainfall amounts in excess of 3 inches are also possible in places that see the most persistent showers and thunderstorms.

**KY Remdesivir Allocation and Request Process is Changing**

The Kentucky Hospital Association will serve as the intermediary for coordinating the state's weekly allocation of Remdesivir from the federal government. Hospitals will continue to request through an online order form, but will be required to set up payment through KHA. UPS Healthcare will continue to ship the purchased Remdesivir to hospitals.

**Full-Dose Clot Prophylaxis for COVID-19 Tied to Mortality  
— But small numbers and retrospective design leave the question open for RCTs**

Preemptive therapeutic-dose anticoagulation for patients hospitalized with COVID-19 wasn't linked to better outcomes in a small observational study.

In fact, relative risk of in-hospital mortality with this strategy was 2.3 times greater ( $P=0.04$ ) than seen with standard prophylactic dosing on multivariate analysis, with 38.7 vs 14.4 deaths per 100 patients.

**Global use of broad-spectrum antibiotics rising**

(CIDRAP) Global consumption of antibiotics that have a greater potential for driving antibiotic resistance nearly doubled from 2000 to 2015, according to a new analysis in *The Lancet Infectious Diseases*. The [study](#), led by researchers from the Center for Disease Dynamics, Economics & Policy (CDDEP), looked at global antibiotic consumption patterns using antibiotic sales data and the World Health Organization's (WHO's) Access, Watch, and Reserve (AWaRe) antibiotic classification framework, introduced in 2017 to provide an indirect indication of the appropriateness of antibiotic use at national and global levels.

The researchers found that consumption of Watch antibiotics—which are broader spectrum drugs that are not recommended for routine use because of their higher potential for resistance—rose by 90.9%. In low- and middle-income countries (LMICs), use of Watch antibiotics rose by 165%.

**FBI Releases 2019 Participation Data for National Use-Of-Force Data Collection**

(IACP News) A news release from the FBI posted on [FBI GOV](#) (7/27) reports that “According to the FBI, 5,043 federal, state, local, and tribal law enforcement agencies submitted use-of-force data to the National Use-of-Force Data Collection for 2019. Agencies submitted data for each qualifying instance of an officer using force. Qualifying uses of force include any action that resulted in the death or serious bodily injury of a person, or the discharge of a firearm at or in the direction of a person. If no qualifying incidents occurred, agencies submitted a zero report for that month. Only agencies that submitted at least one incident report or zero report for 2019 were included in this total.” The FBI “developed the National Use-of-Force Data Collection at the request of major law enforcement organizations that noted the lack of nationwide statistics on the topic. Participation by law

enforcement agencies is entirely voluntary. For the data collection's inaugural year, the agencies submitting 2019 data represented 41% of all federal, state, local, and tribal sworn officers. Participation details for federal agencies and states can be found on the FBI's Crime Data Explorer."

The [Knoxville \(TN\) News Sentinel](#) (7/28, Whetstone) reports, "Knoxville City Council members will decide whether to approve a pilot program that pairs a behavioral health professional with a police officer – a move designed to help Knoxville residents in the throes of a mental health crisis but one some experts said could increase distrust in police." The police department "says the program is a step toward improving the response when police are called for a person who is in a behavioral health crisis. The presence of a behavioral health professional would provide police with different options during their response, but some health professionals told Knox News pairing a social worker with an officer can exacerbate issues the person is experiencing."
