KY COVID UPDATE for October 7

(From <u>Press Release</u>) Due to an upload of a significant backlog of case data from Lexington-Fayette County, the majority of today's cases are from weeks past. The actual number of new cases today without the backlog is 926.

As of 4 p.m. Oct. 6, Gov. Beshear said there were at least 76,587 coronavirus cases in Kentucky, 2,398 of which were newly reported Wednesday. Three hundred and fifty-eight of the newly reported cases were from children ages 18 and younger, of which 38 were children ages 5 and under.

Unfortunately, Gov. Beshear reported five new deaths Wednesday, raising the total to 1,218 Kentuckians lost to the virus. As of Wednesday, there have been at least 1,568,542 coronavirus tests performed in Kentucky with a positivity rate of 4.21%. To see all recent daily reports, <u>click here</u>.

Kentucky Covid Numbers Spike But Hospitalizations Remain Stable

(WEKU) Kentucky Public Health Commissioner Dr. Steven Stack says coronavirus cases are escalating while hospitalization levels are not increasing at the same rate. During Tuesday's capitol briefing, Stack said that's partly because more young people are testing positive, but not requiring hospital care.

declined in four states and Puerto Rico. The virus is not under control, or anywhere close to it. That's especially true in Washington, D.C., where the outbreak tied to the White House appears to be increasing the caseload. The District experienced a 26% increase last week, rising from about 40 new cases per day to about 50. Nationwide, cases were up 6%, compared to the week before. The U.S. is now averaging roughly 43,700 new infections per day.

• Increases continue to span every region of the country.

• Infections are rising in the New York region, which has largely had the virus under control in the months since it became the epicenter for the outbreak, and in parts of the southwest, which saw big spikes over the summer.

• Just four states — Hawaii, Kansas, North Carolina and South Carolina — saw the pace of new infections slow over the past week.

NIOSH National Webinar Elastomeric Half Mask Respirator (EHMR) Strategy for Use in Healthcare Settings During an Infectious Disease Outbreak/Pandemic Tuesday, October 13, 2020 1:00:00 PM EDT - 2:00:00 PM EDT

Elastomeric half mask respirators (EHMRs) are reusable respirators that may be worn in a healthcare setting and supplement the supply of disposable respirators available to healthcare workers. The National Institute for Occupational Safety and Health (NIOSH)—in coordination with the Strategic National Stockpile—posted a Federal Register Notice (FRN) titled "A National Elastomeric Half Mask Respirator (EHMR) Strategy for Use in Healthcare Settings During an Infectious Disease Outbreak/Pandemic".

Through this FRN, <u>NIOSH is seeking input regarding the national distribution plan of purchased EHMRs, as well</u> as identifying potential organizations interested in receiving a portion of these EHMRs with the commitment to provide a report of user acceptability and feasibility of implementation.

Delta strengthens back to Category 2 force as it heads for US

(AccuWeather) Hurricane Delta restrengthened into a Category 2 storm, packing maximum sustained winds of



100 mph, overnight over the warm waters of the Gulf of Mexico. At 11 a.m. CDT Thursday, Delta's winds had reached 105 mph and was only a few miles per hour away from major hurricane status. The storm is expected to ramp back up to major hurricane force -- Category 3 -before it charges toward southwestern Louisiana late Friday as the 10th storm to strike the United State this hurricane season. The turn to the north is forecast to occur Thursday and Thursday night, with the likelihood of a turn more to the northeast on Friday.
