KY Governor says “Masks Crucial as Cases Rise”

([From Press Release](#)) Gov. Andy Beshear on Friday said Kentuckians must wear masks to prevent further spread of the novel coronavirus 2019 (COVID-19) as cases rise across Kentucky and [the rest of the United States](#).

“This week has been a tough week, with three out of the five highest days for new COVID-19 cases,” said Gov. Beshear. “This virus is everywhere. It is in your community. We need every community doing what it takes to defeat it.”

As of 4 p.m. Oct. 23, Gov. Beshear reported the following COVID-19 numbers:

- New cases today: 1,457
- New deaths today: 16
- Positivity rate: 5.34%
- Total deaths: 1,396
- Currently hospitalized: 819
- Currently in ICU: 205
- Currently on ventilator: 97
