### **Gov. Beshear joins Bipartisan Coalition of Governors to Urge Safety Before Holidays**

“This may be the most difficult time yet in our struggle with COVID-19, especially with the holidays approaching. Until the vaccine is available to everyone and until we eradicate this virus once and for all, we must continue working to protect one another,” the governors said. “The science is settled: The best way we can protect our front-line workers and slow the spread of this virus is to double down on mask wearing, social distancing, and washing hands frequently. If you are planning to travel or gather with other households for the holidays, we urge you to reconsider. Just one infection can cause an outbreak in your community, which could overwhelm our hospitals and put you and your loved ones at risk. We owe it to the brave men and women serving on the front lines of this pandemic to do our part and be smart this holiday season.”

This is the second time this bipartisan group of governors has joined forces in the past month to encourage people in their region to do their part to protect our families, front-line workers and small businesses. They released a [similar video](#) prior to Thanksgiving urging families to reconsider holiday travel.

### ----- **COVID Update for Tuesday, December 15**

New cases reported were 2,946, with 340 18 and under. There were 15 new deaths reported. Positivity was 8.3%. 1,788 are hospitalized, with 438 in an ICU and 246 on vents.

### ----- **Ohio Valley Hospitals Filling Up Thanks To COVID-19 Surge**

(WFPL) that many hospitals in the Ohio Valley are under strain, running short of bed space, especially for the most critically ill. The following graphs show how the pandemic is affecting hospital capacity in Kentucky, Ohio and West Virginia, and you can check out the map view [here](#). The [data](#), based on reports by hospitals to HHS, shows that the rise in COVID-19 hospitalizations is putting pressure on the health care system with hospitals in several dozen counties in the region running either at capacity or dangerously close. For this data analysis, the ReSource used the 7-day averages for hospital capacity in Kentucky, Ohio and West Virginia for the week starting November 27. ### **US agencies hacked in monthslong global cyberspying campaign**

(ABC) U.S. government agencies and private companies rushed Monday to secure their computer networks following the disclosure of a sophisticated and long-running cyber-espionage intrusion suspected of being carried out by Russian hackers.

The full extent of the damage is not yet clear. But the potential threat was significant enough that the Department of Homeland Security’s cybersecurity unit directed all federal agencies to remove compromised network management software and thousands of companies were expected to do the same.

What was striking about the operation was its potential scope as well as the manner in which the perpetrators managed to pierce cyber defenses and gain access to email and internal files at the Treasury and Commerce departments and potentially elsewhere.

The intrusion was stark evidence of the vulnerability of even supposedly secure government networks, even after well-known previous attacks.

The identity of the perpetrator remained unclear. A U.S. official, speaking on condition of anonymity because of an ongoing investigation, told The Associated Press on Monday that Russian hackers are suspected.

The Washington Post, citing unnamed sources, said the attack was carried out by Russian government hackers who go by the nicknames APT29 or Cozy Bear and are part of that nation's foreign intelligence service.

The intrusion came to light after a prominent cybersecurity firm, FireEye, determined it had been breached and alerted that foreign governments and major corporations were also compromised. The company did not say who it suspected, though many experts believed Russia was responsible given the level of skill involved.
