Long-Term Care Facilities Receive First COVID-19 Vaccines

(<u>From press release</u>) Today, Gov. Andy Beshear announced that several long-term care facilities in the commonwealth began administering the Pfizer-BioNTech COVID-19 vaccine. On Monday, the Governor showed <u>images from the first long-term care residents</u> in Kentucky to get a shot of the coronavirus vaccine authorized by the U.S. Food and Drug Administration.

The Governor reviewed the Moderna vaccine which is being sent out this week:


- TODAY 10,800 doses went out to 16 local health departments
- TUESDAY 45,200 doses will go to 71 hospitals; and 15,600 doses to 81 local health departments
- WEDNESDAY 1,300 doses will go out to 7 hospitals; and 100 doses will go to 1 more health department.

Overall in December, here is what is expected at this point:

Pfizer vaccines Dec 13-19 38,025
 Pfizer vaccines Dec 20-26 27,300
 Moderna vaccines Dec 20-26 76,700
 Moderna vaccines Dec 27-31 33,800

The Governor said the Washington Post is reporting a new death in the US every 33 seconds. And he noted they said that "In every state but Kentucky, more intensive care unit beds are in use than were in use three months ago." He noted this as positive news.

National Organizations Call for Action to Implement Crisis Standards of Care During COVID-19 Surge (National Academy of Medicine) The crisis is now: governors, health departments, hospitals, and other health care sector partners must take immediate action to save lives and fairly allocate limited resources. Hospitals across most of the United States are experiencing alarmingly high surges in COVID-19 patients, and many

intensive care units across the country are already over capacity and many more will be so in the coming weeks. In response, hospitals are canceling admissions and non-emergency procedures, identifying ways to augment staff, transferring patients outside their local jurisdictions, and even establishing and operating alternate care sites. Many of the hardest-hit hospitals are those that serve Black, Brown, Asian, and tribal communities, threatening to exacerbate existing inequities in care quality and outcomes.

Wildfire Smoke, a Potential Infectious Agent (Science) Wildland fire is a source for bioaerosols that differ in composition and concentration from those found under background conditions, and most of these microbes in smoke are viable. However, the risk of infection to the upper and lower respiratory tract after exposure to wildfire smoke is frequently overlooked. Smoke-related immunologic deficits and inflammatory responses may exacerbate the effects of inhalation of airborne microbial particulates and toxicants in smoke. The intersection of these epidemiological trends and smoke microbial content has yet to be addressed in public health and atmospheric sciences, despite compelling overlaps of increasing mycoses rates and increasing wildfire smoke in some locations.

Congressional Leaders Reach Deal On \$900 Billion COVID-19 Relief Package (NPR) After months of partisan squabbling, congressional leaders have reached agreement on a nearly \$900 billion coronavirus relief package. Among its provisions, the package includes a new round of direct payments to qualifying Americans, worth up to \$600 per adult and child; a boost in weekly unemployment benefits; and funds for small-business aid and vaccine distribution.
