## 'Superbug' fungus spread in two US cities Nursing home and hospitals involved

(AP) U.S. health officials said Thursday they now have evidence of an untreatable fungus spreading in two hospitals and a nursing home. The "superbug" outbreaks were reported in a Washington, D.C. nursing home and at two Dallas-area hospitals, the Centers for Disease Control and Prevention reported. A handful of the patients had invasive fungal infections that were impervious to all three major classes of medications.

The fungus, [Candida auris](#), is a harmful form of yeast that is considered dangerous to hospital and nursing home patients with serious medical problems. It is most deadly when it enters the bloodstream, heart or brain. Outbreaks in health care facilities have been spurred when the fungus spread through patient contact or on contaminated surfaces.

## Massive internet outage: FedEx, Delta and McDonald's go down

(CNN) A sweeping internet disruption on Thursday briefly took out a wide range of major corporate websites — from FedEx and Delta Air Lines to HSBC and McDonald's.

The outages coincided with reports of system disruptions from Akamai ([AKAM](#)) and Oracle ([ORCL](#)), two key providers of [internet infrastructure services](#). Oracle said Thursday afternoon that its outage was the result of Akamai's service disruption. Akamai's Edge DNS service helps route web browsers to their correct destinations and also provides a security service.

Later Thursday afternoon, [Akamai explained](#) that the outage was caused by a "software configuration update triggered a bug in the DNS system." It confirmed that the disruption lasted "up to an hour" and was not the result of a cyberattack.

This is the third major internet outage in two months, and the second involving Akamai.

## US renews 'public health emergency' due to Covid-19 pandemic

(CNN) The United States remains under a state of "public health emergency" due to the Covid-19 pandemic. On Monday, US Department of Health and Human Services Secretary Xavier Becerra [signed a renewal of the determination](#) that a "public health emergency" exists due to the Covid-19 pandemic.

The determination was last renewed in April and was set to expire -- as it is up for renewal every 90 days. This latest renewal is effective starting Tuesday and will continue for another 90 days.

A [public health emergency declaration](#), which can last for the duration of the emergency or 90 days, allows for the emergency use authorization of vaccines, the access of certain funds to address the emergency, and the deployment of military trauma care providers, among other factors.

## Gov. Beshear reports 933 new COVID-19 cases; 6.63% positivity rate

(WKYT) - Governor Beshear reported 933 new COVID-19 cases on Thursday, bringing the state total to 473,503 cases. The governor says the state is seeing a 6.63% positivity rate. Of Thursday's new cases, 220 are in kids 18 or younger. There were two new COVID-19 related deaths reported on Thursday. That brings the state total to 7,308.

As of Thursday, 423 people are hospitalized for COVID-19 related reasons, 124 are in the ICU, and 50 are on ventilators. The governor reported 2,256,171 Kentuckians have been vaccinated.

## Vaccinations rise in some states with soaring infections

(AP) Vaccinations are beginning to rise in some states where COVID-19 cases are soaring, White House officials said Thursday in a sign that the summer surge is getting the attention of vaccine-hesitant Americans as hospitals in the South are being overrun with patients.

Coronavirus coordinator Jeff Zients told reporters that several states with the highest proportions of new infections have seen residents get vaccinated at higher rates than the nation as a whole. Officials cited Arkansas, Florida, Louisiana, Missouri and Nevada as examples.

## Hospital lobbies for COVID-19 vaccine requirements for healthcare workers

An increasing number of health systems are mandating COVID-19 vaccines for employees as the nation sees cases and hospitalizations continue to rise.

Just this week, Arizona's largest private employer, Banner Health, announced that it, too, would require employees to obtain a COVID-19 vaccine by the fall. Banner Health [joins a growing number](#) of hospitals and providers taking this step, including Houston Methodist, Henry Ford Health System and Mass General Brigham. Some of the facilities making the requirement have moved ahead with firing employees that don't comply.

Due to the risks of the disease, AHA "strongly urges the vaccination of all health care personnel," but its most recent statement does not ask its members to require the vaccine. AHA said if providers mandate vaccines they should also make sure to provide exemptions for medical reasons, including those backed by the Equal Employment Opportunity Commission.

On Wednesday, National Institute of Allergy and Infectious Diseases Director Anthony Fauci, who also advises the White House on pandemic response, said in light of the delta variant vaccinated people [may want to consider](#) wearing a mask indoors, particularly in regions of the country with high levels of disease. He does anticipate local authorities may require masks again due to the uptick in cases but doesn't expect lockdowns or a national mask mandate.

## As extreme heat becomes more common, ERs turn to body bags to save lives

(NBC) As a deadly [heat wave scorched the Pacific Northwest](#) last month, overwhelming hospital emergency rooms in a region unaccustomed to triple-digit temperatures, doctors resorted to a grim but practical tool to save lives: human body bags filled with ice and water.

Officials at hospitals in Seattle and Renton, Washington, said that as more people arrived experiencing potentially fatal heatstroke, and with cooling catheters and even ice packs in short supply, they used the novel treatment to quickly immerse and cool several elderly people.

Zippering heatstroke patients into ice-filled body bags worked so well that it could become a go-to treatment in a [world increasingly altered by climate change](#), said Dr. Alex St. John, an emergency physician at UW Medicine's Harborview Medical Center.

## CIA Director Renews Efforts To Solve 'Havana Syndrome' Mystery

(NPR) CIA Director William Burns says he has redoubled the agency's efforts to uncover the cause of [Havana syndrome](#) — the mysterious set of ailments that has afflicted more than 200 U.S. officials and family members around the world.

That includes the assignment of a senior officer who once led the hunt for Osama bin Laden to lead the investigation and tripling the size of a medical team involved in the probe, Burns told NPR on Thursday in his first sit-down interview since being confirmed as the agency's chief in March.

### **How hackers can control your phone through a missed call & expose your info – even if you never click on encrypted link**

(NewsBreak) EXPERTS are warning against a new severe threat to privacy and data security on smartphones as hackers use tricks such as a missed call to control devices.

Victims may be completely unaware that they were [exposed to the hack](#) and never even notice there is suspicious behavior on their phones.

[The cyberattack uses](#) a technique known as a zero-click hack which does not require the victim to click on an encrypted link to be caught.

The hack can be carried out without any voluntary action from the victim, unlike the typical cyber-attack where traps are laid out to trick people into clicking on a vulnerable URL or downloading an attachment with embedded malware.

[The zero-click hack](#) instead takes advantage of flaws in your device. It uses these flaws to sidestep the data verification generally needed to get into a phone.

### **NSA Cybersecurity Workforce Certificate Program Recruiting Health Care Professionals**

The University of Louisville is launching a new NSA Cybersecurity Pathway Program. UofL is leading a coalition with five different schools to implement a national cybersecurity in health care curriculum.

This pilot program, sponsored by the National Security Agency, intends to recruit about 200 participants within its first year. The program is working to recruit transitioning military, veterans (including current U.S. Armed Reserves and National Guard members) and first responders (i.e., law enforcement, health care workers and IT specialists within health care) looking to enhance their skill set or possibly make a career change. UofL is offering \$1,500 scholarships for these specified participants. There are 40 new scholarships for the cohort starting on November 22, 2021, that will be awarded on a first come, first serve basis.

Participants will have the opportunity to earn industry badges from big tech companies such as Google, Microsoft and IBM.
