the U.S. Department of Health and Human Services are committed to transparent communication regarding the COVID-19 monoclonal antibody treatments currently authorized for emergency use in certain patients with COVID-19.

FDA and ASPR are announcing the authorization of an extension to the shelf-life from 12 months to 18 months for the refrigerated Eli Lilly monoclonal antibody, bamlanivimab, which is currently authorized for emergency use only when administered together with etesevimab. As a result of this extension, unopened vials of bamlanivimab, injection, 700 mg/20 mL, should be stored under refrigerated temperature at 2°C to 8°C (36°F to 46°F), and may be stored for an additional 6 months from the labeled date of expiry (See Table 1 below). FDA granted this extension following a thorough review of data submitted by Eli Lilly. This extension applies to all unopened vials of bamlanivimab that have been held in accordance with storage conditions detailed in the authorized [Fact Sheet for Health Care Providers](#) and the [Letter of Authorization for Emergency Use Authorization \(EUA\) 094 for bamlanivimab and etesevimab](#), administered together.

The bamlanivimab authorized to be administered together with etesevimab under the EUA has fixed expiration dates on the label of each vial and carton. The date identified on the vial and carton reflects the original shelf-life expiry of 12 months and does not reflect the extended 18-month shelf-life expiry. The national pause on distribution of bamlanivimab and

etesevimab remains in effect. We recommend that providers use alternative authorized monoclonal antibody therapies until further notice.

## Most U.S. teens, young adults want to get COVID-19 vaccine, survey finds

(UPI) Most teens and young adults want to get vaccinated against [COVID-19](#), a survey published Friday by [JAMA Health Forum](#) found. About 75% of people ages 14 to 24 years in the United States who responded to the survey, conducted by the University of Michigan's Institute for Healthcare Policy and Innovation, said they would get the shot, the data showed. Most agreed with the statement that vaccination was important to "help stop the spread [of the virus], as well as get back to normal as soon as possible," the researchers said.

## [30% of new cases Fri. were 18 and younger; infections close schools:](#)

### [Ky. rate is 6th in U.S.; state's ventilator count sets record](#)

(Ky Health News – Al Cross) As the pandemic keeps accelerating in Kentucky, and almost all schools are in session, the coronavirus keeps infecting more young people. And in some places, so many are infected that schools are closing. Kentucky reported another 3,869 cases of the coronavirus Friday, 1,158 of them in people 18 and younger. That's 29.9 percent, which appears to be the highest percentage of young victims ever on the state's [daily report](#).

**Fayette County Public Schools** reported 208 cases in students through Thursday, 110 of them between ages 5 and 11, not eligible for vaccination. At the schools' request, the local health department held vaccination clinics.

Infections force students into quarantine. The school district said Jessie Clark Middle School reported 10 students and four staff testing positive since the first day of school, leading to quarantines for 304 students, [reports](#) Valarie Honeycutt Spears of the **Lexington Herald-Leader**.

Spears also [reports](#) that **Magoffin County Schools** will be closed through Aug. 29 due to coronavirus infections and will not offer remote instruction. The district and **Jenkins Independent Schools** "are among the latest districts to tell kids and staff to stay out of schools for extended periods," Spears reports. "The Lee County and **Knott County** school districts have also canceled classes this school year for various periods as a result of the coronavirus case surge."

Kentucky's surge has given it the sixth highest infection rate among the states over the last two weeks, according to **Centers for Disease Control and Prevention** data analyzed by **The New York Times**. The states with higher rates are Mississippi, Louisiana, Florida, Arkansas and Alabama. After Kentucky, the next three states are also in the South: Georgia, South Carolina and Tennessee.

### **To Improve Opioid Addiction Treatment, ERs Get Creative**

(NPR) A [recent report](#) from the Legal Action Center and the Bloomberg American Health Initiative found that despite widespread consensus on the importance of addiction treatment in the ER and an [unprecedented rise in overdose deaths](#), many hospitals fail to screen for substance use, offer medications to treat opioid use disorder or connect patients to follow-up care.

Many patients who don't receive those services die shortly after discharge or within a year of their ER visit, the report says. But a growing number of emergency rooms and health professionals are trying to change that by developing new approaches that address the missed treatment opportunity in ERs.

### **FBI sending more agents to Louisville to curb violence**

(WAVE) As Louisville's criminal activity rises, the Federal Bureau of Investigation is doubling down on its effort to drive crime out of the city. FBI agents are partnering with the Louisville Metro Police Department to target gangs and violent criminal groups, called the Safe Streets Task Force. Soon, more FBI agents will be in the area to put a hyper focus on these efforts.

"The main objective of a Safe Streets Task Force is to look at what we call 'enterprise investigation,'" FBI Louisville's Assistant Special Agent in Charge Brian Jones said.

The goal of the task force is to go after violent gangs and other criminal groups so Louisville's crime rate can be slowed, Jones said. "We want to make an impact by targeting a whole gang at what time or a whole crew."

## **Elon Musk's satellites beam internet into remote locations of US Expanded pilot project in Chilean fishing hamlet**

(Reuters) Starlink, a division of SpaceX, aims to roll out 12,000 satellites as part of a low-Earth orbiting network to provide low-latency broadband internet services around the world, with a particular focus on remote areas that terrestrial internet infrastructure struggles to reach.

Since October, it has been [offering](#) a 'Better Than Nothing Beta' program to subscribers in the United States, while also running pilot trials in other countries. In Chile, a second antennae will be installed in Caleta Sierra, a small fishing port close to the arid northern deserts.

## **GM recalls all Chevy Bolts due to fire risk, says owners should park outside and limit charging**

(CBS) General Motors is recalling all Chevrolet Bolt electric vehicles sold worldwide to fix a battery problem that could cause fires, expanding a previous recall. The company last month told owners of 2017-2019 model year vehicles to [park outdoors and not charge them overnight](#) after two vehicles repaired in the earlier recall caught fire. The recall and others raise questions about lithium ion batteries, which now are used in nearly all electric vehicles. Ford, BMW and Hyundai all have recalled batteries recently.
